

**Aluminum Columns:**

The HB&G Companies Aluminum Column Limited Lifetime Warranty and Limited One (1) Year Factory Applied Top Coat Color Fade Paint Warranty are extended to original purchasers of the HB&G Companies Aluminum Column. This warranty is for the benefit of the original homeowner who purchased the product and is not transferable. We warrant that the HB&G Companies Aluminum Column when properly installed shall be free of manufacturing defects in workmanship and materials under conditions of normal use and service. If the HB&G Companies Aluminum Column fails to perform as warranted and meets the criteria laid forth in the warranty provisions, HB&G Companies, at its option, will (1) provide replacement parts at no charge; or (2) allow a factory authorized repair at no charge (HB&G factory authorized repair will be completed by agreed upon third party); or (3) refund the purchase price or the retailer's/dealer price at the time of the original purchase for any component of the HB&G Companies Aluminum Column that has failed as a result of defective material or workmanship. Such replacement or authorized repair is warranted for the remainder of the limited warranty period unless otherwise specified by HB&G. Installation and labor costs are not covered under this warranty. Dated proof of purchase is required to affect a claim against HB&G Companies Material.

**General Conditions & Exclusions:**

The HB&G Companies Aluminum Column Limited Lifetime Warranty and Limited One (1) Year Factory Applied Top Coat Color Fade Paint Warranty are not transferable, and are subject to these general conditions & exclusions:

There are certain conditions or applications over which HB&G Companies has no control. The HB&G Companies Aluminum Column Warranty does not cover defects or problems as a result of such conditions or applications.

**What is not covered:**

- Damage caused by improper installation, use, applications or maintenance.
- Damage caused by environmental conditions or use that exceeds design standards.
- Damage caused by accidents, Acts of God, abuse, vandalism, animal activity or any other external force.
- Damage resulting from mishandling in transit if within customer's control.
- Modifications or improvements made to the column by seller or any other party such as splitting the column.
- Normal weathering, chalking, fading, atmospheric pollutants or mildew buildup.
- Non-factory applied finishes, applied sealants or caulking.
- Installation or labor costs.
- Loss of time, profit or any other liability associated when the product is installed in violation of building codes.
- The purchase, damage, repair or replacement of products not manufactured by HB&G Companies.

The limited warranties set forth are the only warranties (whether written or oral) applicable to HB&G Companies Aluminum Columns. By purchasing or using the product covered by this Limited Warranty, Buyer and User agree that they are not relying on any oral statements made by anyone that are in any way contrary to this Limited Warranty.

HB&G Companies makes no other warranties, express or implied and makes no implied warranties of merchantability or fitness for a particular purpose. HB&G Companies liability shall in all instances be limited to repair of the material purchased, replacement of the material only or refund of your original purchase price of the product. The remedies stated above are your sole and exclusive remedy and HB&G Companies will not be responsible for incidental or consequential damages relating to your purchase or use of HB&G Companies Materials.

This warranty is only applicable in the United States & Canada.
